Ethical recruitment

The Supplier shall not deny anyone belonging to an ethnic, religious or linguistic minority the right to enjoy their culture, to report and practise their religion or to use their language.

Information on data disclosure

The supplier has a controlled release or disclosure of information (disclosures) to another person or organization. Disclosure is the process of making facts or information available to the public. Authorized disclosure by Supplier is the act of informing its customers, investors and analysts of relevant information to the extent permitted in writing by the SLU.

The Supplier fully respects and applies the requirements of the GDPR (General Data Protection Regulation) as general principles for the protection of personal data within the meaning of the European Union regulations governing the protection of individuals in connection with the processing of personal data, which is one of the fundamental human rights. The supplier's actions must respect the principles for the protection and preservation of information regarding private and family life, as well as the retention of sensitive information about others. The scope of GDPR compliance also includes employees of sub-contracting organizations or natural persons who provide their services to the supplier.

Competition fairness and anti-dumping (anti-discrimination) policy

The supplier is committed to establishing, in its own operations, their subsidiaries and joint operations, for its employees and the appointed personnel, consultants and agency workers working for its business partners, policies and practical measures on fair competition, aiming at:

interests of the company for which they work. It also regulates the obligations of employees and the company so that there is no conflict with the interests of the SLU.

Fake (imitated) products

The supplier shall be responsible for taking effective measures within his manufacturing site to prevent the use in his processes of products where:

- Fake products are marketed as genuine products with proven origin;
- The origin or quality of the products offered is incorrectly stated.

Intellectual property

Vendor is required to enter into a written commitment from the SERVICE to "Maintain Data Confidentiality" marked as a "Non Disclosure Agreement".

The Supplier aligns its processes to the requirements for maintaining "Cybersecurity".

The Supplier is obliged to establish effective measures to protect the intellectual property SLU for the areas:

- Any product documentation provided by the SLU;
- Protection of distinctive signs, in particular trademarks (which distinguish goods of the SLU from those of other undertakings) and geographical indications (which identify goods as originating in the place where characteristic is given to their geographical origin).

Export control and compliance with economic sanctions

The Supplier shall establish rules and processes to ensure that it does not participate in prohibited trades.

Economic sanctions and controls on imports or exports are restricted by national governments or international conventions to which the national government agrees. Conventions may prohibit trade with specific individuals, entities or countries, or restrict or prohibit exports or imports of certain goods or services.

SLU reserves the right to take over from the supplier goods or services, the import or export of which falls under formalized restrictions.

The Supplier is obliged to carry out an inspection of the exercise of reasonable care regarding the Company's activities in the course of its business. The due diligence review must include an examination of the economic, legal, fiscal and financial circumstances of the undertaking or employees, sales data, stakeholder expectations and examinations of whether negative activities, corruption and tax evasion have been prevented.

Greenhouse gas emissions

Climate change mitigation is action to limit climate change by reducing greenhouse gas emissions or removing those gases from the atmosphere.

The increase in the global average temperature is mostly due to emissions from the combustion of fossil fuels (coal, oil and natural gas)

The supplier either directly creates conditions and manages the operation of its own optimal use of water resources in order to minimize the consumption of sanitary and drinking water and subsequent measures with minimizing the risks of reduced water quality. Air quality

If it depends on air protection management from external suppliers, it has internal control processes in place to immediately alert and request remediation in cases of violation of provisions in accordance with applicable legislative and other regulations (laws, decrees, customer requirements) to protect air quality.

Management of dangerous substances

The supplier has established an internal management system in internal processes to ensure compliance with national and international legislative and other regulations for environmental safety.

This must include:

- Comprehensive and updated inventory of stored chemicals;
- Material Safety Data Sheet (MSDS) layout and update system;
- Controlled process of approval of procured chemicals and their own application in internal main and auxiliary processes;
- The process of early prior training of workers in the use of hazardous substances:
- Process for the management, use and consumption of chemicals;
- The process for the disposal of waste from hazardous substances in accordance with currently valid national legislative and other regulations.

The supplier is able to create and enter data into the IMDS (International Material Data System) database on materials used for car manufacturing.

Sustainable resource management

The supplier understands the requirements for resource sustainability, follows expectations for the development of resource sustainability initiatives. It spreads awareness among its workers and collaborators that resources need to be actively managed so that they are not depleted in the context to such an extent that future generations will be affected.
